If you were cited for any of the following, you are NOT eligible to take the driver safety course for dismissal:

- \*\* Speeding 25 mph or more above the posted speed limit
- \*\* NO insurance or failure to maintain financial responsibility
- \*\* Leaving the scene of a collision
- \*\* Passing a School Bus
- \*\* Cited while driving in a Construction Zone while worker's were present
- \*\* You have a Commercial Driver's License

YOU MAY ONLY TAKE THE DRIVER SAFETY COURSE FOR DISMISSAL ONCE A YEAR. THAT IS FROM THE COMPLETION DATE OF THE PRIOR CLASS TO THE DATE OF THE NEW VIOLATION.

In order to dismiss your citation, you MUST provide all of the following to the court by \_\_\_\_\_.

- 1.) A valid Texas Driver's License or permit.
- 2.) Proof of financial responsibility (Valid Automobile Liability Insurance)
- 3.) The attached notarized affidavit.
- 4.) A certified copy of your driver's record (you may use attached form and mail to DPS and DPS WILL RETURN IT DIRECTLY TO THE COURT or you may obtain it on your own through DPS)
- 5.) Present a uniform certificate of driver safety course completion from a Texas Education Agency approved course. (PLEASE NOTE: IT MAY TAKE UP TO 30 DAYS TO RECEIVE THE CERTIFICATE AND YOU WILL NEED TO HAVE THAT TO THE COURT BY THE DESIGNATED DATE)

\*\*\*\*\* PLEASE NOTE \*\*\*\*\*

FAILURE TO COMPLETE ANY AND ALL OF THESE REQUIREMENTS BY REQUIRED DATE WILL RESULT IN A FORFEIT OF YOUR RIGHT TO DISMISS YOUR CITATION WITH THE DRIVER SAFETY COURSE AND THE CONVICTION WILL GO ON YOUR DRIVING RECORD. IN ADDITION, YOUR FINE AMOUNT WILL NOT BE DISMISSED AND YOUR CASH BOND WILL BE KEPT FOR PAYMENT OF SAID FINE.

Upon completion of all the above, your cash bond will be returned to you by check.

\*\* I have a valid non-commercial Texas driver's license or permit.

\*\* I have proof of a valid vehicle insurance policy or proof of financial responsibility, listing me as a covered driver,

\*\* I am not in the process of taking a Driver Safety Course or Motorcycle Operator's Training Course, if applicable (Under Section §45.0511 CCP) and I have not completed a Driver Safety Course or Motorcycle Operator's Training Course, as applicable, that is not shown on my driving record within the last 12 months preceding the date of the offense.

I WAIVE MY RIGHT TO TRIAL BY JUDGE OR JURY, enter a plea of NO CONTEST OR GUILTY, and understand that I have 90 DAYS from my initial plea date to take an approved course and submit the certificate of completion to the court.

I understand that if I complete a driving safety course within the required time, the charge against me will be dismissed and the court will report to the Department of Public Safety the completion date of the driving safety course for inclusion on my driving record.

I understand that I have given the court a cash bond in equal to my fine. If I complete the above requirements, my fine will be returned to me via check. I further understand that if I fail to present to this court proof of completion of the driving safety course within the time required, the violation will be reported to DPS and the cash bond will be retained by the court in order to fulfill my fine requirements to said court and State.
